# A CUBIC IDENTITY FOR THE INFELD-VAN DER WAERDEN FIELD AND ITS APPLICATION. 

R. A. Sharipov


#### Abstract

A cubic identity for the Infeld-van der Waerden field is found and its application to verifying an explicit formula for the spinor components of the metric connection is demonstrated.


## 1. Introduction.

The Infeld-van der Waerden field $\mathbf{G}$ is a special spin-tensorial field associated with the bundle of Weyl spinors $S M$ over the four-dimensional space-time manifold $M$ in general relativity. Along with the spinor metric d, the Infeld-van der Waerden field $\mathbf{G}$ forms the basic equipment of the spinor bundle $S M$. In this role $\mathbf{d}$ and $\mathbf{G}$ are similar to the metric tensor $\mathbf{g}$ of $M$. The fields $\mathbf{d}, \mathbf{G}$, and $\mathbf{g}$ are related to each other through a series of identities, e. g. we have

The identities (1.1) were considered in [1]. They are quadratic with respect to the components of the Infeld-van der Waerden field G. Here we consider the identity

which is cubic with respect to the components of $\mathbf{G}$.
The metric tensor $\mathbf{g}$ is canonically associated with its metric connection $\Gamma$. The metric connection $\Gamma$, in its turn, has an extension $(\Gamma, A, \bar{A})$ to the spinor bundle $S M$. The spinor components $\mathrm{A}_{r j}^{i}$ of this extension are given by the formula

[^0]The formula (1.3) was derived in [1] by means of direct, but rather huge calculations. In this paper we verify this formula with the use of the identity (1.2).

## 2. Coordinates and frames.

The components of a vector and the components of a tensor are always relative to some basis. In the case of vectorial and tensorial fields we should have bases at each point of the space-time manifold $M$. Thus we come to the concept of a frame.

Definition 1.1. A frame of the tangent bundle $T M$ is a quadruple of vector fields $\mathbf{\Upsilon}_{0}, \mathbf{\Upsilon}_{1}, \mathbf{\Upsilon}_{2}, \mathbf{\Upsilon}_{3}$ defined in some open domain of $M$ and linearly independent at each point of this domain.

Let $\mathbf{\Upsilon}_{0}, \mathbf{\Upsilon}_{1}, \mathbf{\Upsilon}_{2}, \mathbf{\Upsilon}_{3}$ be a frame of the tangent bundle $T M$ Then the commutator $\left[\boldsymbol{\Upsilon}_{i}, \boldsymbol{\Upsilon}_{j}\right]$ is a vector field that can be expressed through the frame fields:

The coefficients $c_{i j}^{k}$ in (2.1) are called the commutation coefficients of the frame $\mathbf{\Upsilon}_{0}, \mathbf{\Upsilon}_{1}, \mathbf{\Upsilon}_{2}, \mathbf{\Upsilon}_{3}$. They are uniquely determined for any frame.

Definition 1.2. A frame $\mathbf{\Upsilon}_{0}, \mathbf{\Upsilon}_{1}, \mathbf{\Upsilon}_{2}, \mathbf{\Upsilon}_{3}$ of the tangent bundle $T M$ is a called a holonomic frame if all of its commutation coefficients $c_{i j}^{k}$ are identically zero.

Once we take some local coordinates $x^{0}, x^{1}, x^{2}, x^{3}$ in the space-time manifold $M$, we get the holonomic frame of the coordinate vector fields

\mathbf{\Upsilon}_{0}=\frac{\partial}{\partial x^{0}}, \quad \mathbf{\Upsilon}_{1}=\frac{\partial}{\partial x^{1}}, \quad \mathbf{\Upsilon}_{2}=\frac{\partial}{\partial x^{2}}, \quad \mathbf{\Upsilon}_{3}=\frac{\partial}{\partial x^{3}} \tag{2.2}
\end{equation*}
$$

defined within the domain of the coordinates $x^{0}, x^{1}, x^{2}, x^{3}$ and naturally associated to them. Local coordinates and their coordinate frames (2.2) are sufficient for most calculations in general relativity where no spinors are involved. However, when dealing with spinors we need to use non-holonomic frames.

Definition 1.3. A frame of the spinor bundle $S M$ is a pair of smooth sections $\Psi_{1}, \Psi_{2}$ of $S M$ defined in some open domain of $M$ and linearly independent at each point of this domain.

Frames of $T M$ are often called spacial frames, while frames of $S M$ are called spinor frames. Having some spacial frame $\mathbf{\Upsilon}_{0}, \mathbf{\Upsilon}_{1}, \mathbf{\Upsilon}_{2}, \mathbf{\Upsilon}_{3}$ and some spinor frame $\boldsymbol{\Psi}_{1}, \boldsymbol{\Psi}_{2}$ with common domain, we can express tensorial and spin tensorial fields through their components forming multi-indexed arrays. The indices of such arrays are subdivided into three groups: spacial indices ranging from 0 to 3, spinor indices, and conjugate spinor indices both ranging from 1 to 2 . Indices within each group can be either upper or lower. The quantities $g_{p q}$ with two lower spacial indices in (1.2) are the components of the metric tensor $\mathbf{g}$, while the quantities $g^{m n}$ are the components of the dual metric tensor. The components of these two tensors form two $4 \times 4$ symmetric matrices inverse to each other:

Similarly, $d_{i j}$ and $d^{i j}$ are the components of the spinor metric and dual spinor metric respectively. They form $2 \times 2$ skew-symmetric matrices inverse to each other:

The Infeld-van der Waerden field $\mathbf{G}$ in (1.1) is presented by the quantities $G_{p}^{r \bar{r}}$. It has one upper spinor index $r$, one upper conjugate spinor index $\bar{r}$, and one spacial index $p$. The quantities $G_{s \bar{s}}^{q}$ are the components of the inverse Infeld-van der Waerden field. They are produced from $G_{p}^{r \bar{r}}$ by raising the spacial index $p$ and lowering the spinor and conjugate spinor indices $r$ and $\bar{r}$ :

G_{s \bar{s}}^{q}=\sum_{r=1}^{2} \sum_{\bar{r}=1}^{2} \sum_{p=0}^{3} G_{p}^{r \bar{r}} g^{p q} d_{r s} \bar{d}_{\bar{r} \bar{s}} \tag{2.5}
\end{equation*}
$$

The quantities $\bar{d}_{\bar{r} \bar{s}}$ in the formula (2.5) are the components of the conjugate spinor metric $\overline{\mathbf{d}}=\tau(\mathbf{d})$. They are related to $d_{i j}$ by means of the complex conjugation:

Similarly, the quantities $\bar{d}^{\bar{i} \bar{j}}$ in the formula (1.3) are defined as follows:

The quantities (2.6) and (2.7) form two mutually inverse matrices:

\sum_{r=1}^{2} \bar{d}_{\bar{j} \bar{r}} \bar{d}^{\bar{r} \bar{i}}=\delta_{j}^{i} \tag{2.8}
\end{equation*}

The equality (2.8) is similar to the above equalities (2.3) and (2.4).
The quantities $G_{p}^{r \bar{r}}$ and $G_{s \bar{s}}^{q}$ satisfy the following identities:

G_{p}^{r \bar{r}}=\overline{G_{p}^{\bar{r} r}}, \quad G_{s \bar{s}}^{q}=\overline{G_{\bar{s} s}^{q}} \tag{2.9}
\end{equation*}
$$

The identities (2.9) mean that for each fixed $p$ and for each fixed $q$ the quantities $G_{p}^{r \bar{r}}$ and $G_{s \bar{s}}^{q}$ form two Hermitian matrices. In the coordinate free form the identities (2.9) are written as $\tau(\mathbf{G})=\mathbf{G}$.

Now let's proceed to the quantities $\omega^{a m b n}$ in the formula (1.2). They are the components of the dual volume tensor. These quantities are produced from the components of the volume tensor $\boldsymbol{\omega}$ by means of the index raising procedure:

Both quantities $\omega^{a m b n}$ and $\omega_{p r q s}$ in (2.10) can be produced from the components of the metric tensor and the components of the dual metric tensor with the use of the Levi-Civita symbol. Indeed, we have the following formula for $\omega_{p r q s}$ :

Similarly, for $\omega^{a m b n}$ we have the formula

\omega^{a m b n}=-\sqrt{-\operatorname{det}\left(g^{i j}\right)} \varepsilon^{a m b n} \tag{2.12}
\end{equation*}
$$

Regardless of the upper and lower positions of the indices, the components of the Levi-Civita symbol are given by the formula

\varepsilon^{a m b n}=\varepsilon_{a m b n}= \begin{cases}0 & \begin{array}{l}
\text { if at least two of the four indices } \\
a b m n \text { do coincide; }
\end{array}  \tag{2.13}\\
1 & \begin{array}{l}
\text { if the indices } a m b n \text { form an even } \\
\text { transposition of the numbers } 0123
\end{array} \\
-1 & \begin{array}{l}
\text { if the indices } a m b n \text { form an odd } \\
\text { transposition of the numbers } 0123 .
\end{array}\end{cases}

Note that the space-time manifold $M$ is assumed to be equipped with three geometric structures: the metric, the orientation, and the polarization (see [2]). The orientation in $M$ means that we can distinguish right and left frames. The formulas (2.11) and (2.12) are written for right frames. Passing to left frames, we should change the sign in the right hand sides of them.

Let's consider the Lie derivatives $L_{\boldsymbol{\Upsilon}_{r}}$ in the formula (1.3). In the case of a holonomic frame (2.2) the operators $L_{\Upsilon_{r}}$ coincide with the corresponding partial derivatives, i.e. $L_{\boldsymbol{\Upsilon}_{r}}=\partial / \partial x^{r}$. In the case of a non-holonomic frame we should expand $\boldsymbol{\Upsilon}_{0}, \boldsymbol{\Upsilon}_{1}, \mathbf{\Upsilon}_{2}, \mathbf{\Upsilon}_{3}$ in some auxiliary holonomic frame:

Then the operators $L_{\boldsymbol{\Upsilon}_{r}}$ in (1.3) act as the differential operators in the right hand sides of the formula (2.14). In other words, for $L_{\boldsymbol{\Upsilon}_{r}}$ we have the expression

formally coinciding with (2.14). The Lie derivatives (2.15) satisfy the relationships

The commutation coefficients $c_{i j}^{k}$ in (2.16) are the same as in the formula (2.1).

## 3. Proof of the identity (1.2).

The proof of the identity (1.2) is similar to that of the identities (1.1) in [1]. It is based on direct calculations. The matter is that the spinor bundle $S M$ is related to the tangent bundle $T M$ through canonically associated frame pairs, while the fields $\mathbf{g}, \mathbf{d}, \mathbf{G}$, and $\boldsymbol{\omega}$ are given by explicit formulas in such frame pairs.

Definition 3.1. A frame $\mathbf{\Upsilon}_{0}, \mathbf{\Upsilon}_{1}, \mathbf{\Upsilon}_{2}, \mathbf{\Upsilon}_{3}$ of the tangent bundle $T M$ is a called an orthonormal frame if the metric tensor $\mathbf{g}$ and its dual metric tensor are given
by the standard Minkowski matrix in this frame:

g_{i j}=g^{i j}=\left\|\begin{array}{cccc}
1 & 0 & 0 & 0  \tag{3.1}\\
0 & -1 & 0 & 0 \\
0 & 0 & -1 & 0 \\
0 & 0 & 0 & -1
\end{array}\right\|
$$

Let's recall again that $M$ is equipped with the metric, the orientation, and the polarization. The polarization is a geometric structure that distinguishes the future half light cone from the past half light cone.
Definition 3.2. A frame $\mathbf{\Upsilon}_{0}, \mathbf{\Upsilon}_{1}, \mathbf{\Upsilon}_{2}, \mathbf{\Upsilon}_{3}$ of the tangent bundle $T M$ is a called positively polarized if its first vector field $\boldsymbol{\Upsilon}_{0}$ belongs to the interior of the future light half cone at each point of its domain.

Definition 3.3. A frame $\boldsymbol{\Psi}_{1}, \boldsymbol{\Psi}_{2}$ of the spinor bundle $S M$ is a called orthonormal if the spinor metric $\mathbf{d}$ is given by the following matrix in this frame:

0 & 1  \tag{3.2}\\
-1 & 0
\end{array}\right\|
$$

Due to the definition 3.3 the dual spinor metric is given by the matrix

$$
d^{i j}=\left\|\begin{array}{cc}
0 & -1 \\
1 & 0
\end{array}\right\|
$$

in any orthonormal frame of the spinor bundle $S M$.
According to the definition of the spinor bundle $S M$ (see [1]), each positively polarized right orthonormal frame $\mathbf{\Upsilon}_{0}, \mathbf{\Upsilon}_{1}, \mathbf{\Upsilon}_{2}, \mathbf{\Upsilon}_{3}$ of the tangent bundle $T M$ is associated with some orthonormal frame $\boldsymbol{\Psi}_{1}, \boldsymbol{\Psi}_{2}$ of the spinor bundle $S M$. Such frames form canonically associated frame pairs. In any canonically associated frame pair the Infeld-van der Waerden field $\mathbf{G}$ is given by the following Pauli matrices:

\end{array}\right\|=\sigma_{0}, & G_{2}^{i \bar{i}}=\left\|\begin{array}{cc}
0 & -i \\
i & 0
\end{array}\right\|=\sigma_{2}  \tag{3.3}\\
G_{1}^{i \bar{i}}=\left\|\begin{array}{ll}
0 & 1 \\
1 & 0
\end{array}\right\|=\sigma_{1}, & G_{3}^{i \bar{i}}=\left\|\begin{array}{cc}
1 & 0 \\
0 & -1
\end{array}\right\|=\sigma_{3}
\end{array}
$$

Substituting (3.3), (3.2), and (3.1) into the formula (2.5), we calculate the components of the inverse Infeld-van der Waerden field:

1 & 0 \\
0 & 1
\end{array}\right\|=\sigma_{0}, & G_{i \bar{i}}^{2}=\left\|\begin{array}{cc}
0 & i \\
-i & 0
\end{array}\right\|=-\sigma_{2},  \tag{3.4}\\
G_{i \bar{i}}^{1}=\left\|\begin{array}{ll}
0 & 1 \\
1 & 0
\end{array}\right\|=\sigma_{1}, & G_{i \bar{i}}^{3}=\left\|\begin{array}{cc}
1 & 0 \\
0 & -1
\end{array}\right\|=\sigma_{3} .
\end{array}
$$

And finally, substituting (3.1) into (2.12), we calculate the components of the inverse volume tensor $\boldsymbol{\omega}$ in the right orthonormal frame $\mathbf{\Upsilon}_{0}, \mathbf{\Upsilon}_{1}, \mathbf{\Upsilon}_{2}, \mathbf{\Upsilon}_{3}$ :

\end{equation*}
$$

The quantities $\varepsilon^{a m b n}$ in (3.5) are defined by the formula (2.13). Now in order to prove the identity (1.2) it is sufficient to substitute (3.1), (3.3), (3.4), and (3.5) into (1.2) and verify that this equality is valid for all particular values of the indices $p$, $q, m, r$, and $\bar{r}$. The following computer code does it for us:

Upon executing the above code it is sufficient to type

and find that the identity (1.2) is proved for any canonically associated pair of frames. Due to the tensorial nature of this identity, being proved for some particular frame pair, it remains valid for arbitrary pairs of frames.

Note that the above code is designed for the Maple ${ }^{1}$ package. However, it can be easily adapted for other symbolic computation packages.

## 4. Other relationships derived from (1.2).

Let's multiply both sides of the identity (1.2) by $G_{m}^{u \bar{u}}$ and sum it over the index $m$. As a result, applying the second identity (1.1), we get

& \quad+\sum_{a=0}^{3} \sum_{b=0}^{3} \sum_{m=0}^{3} \sum_{n=0}^{3} i g_{p a} g_{q b} \omega^{a m b n} G_{m}^{u \bar{u}} G_{n}^{r \bar{r}} \tag{4.1}
\end{align*}

[^1]Symmetrizing the equality (4.1) with respect to $p$ and $q$, we derive

G_{p}^{r \bar{u}} G_{q}^{u \bar{r}}+G_{q}^{r \bar{u}} G_{p}^{u \bar{r}}=G_{p}^{r \bar{r}} G_{q}^{u \bar{u}}+G_{q}^{r \bar{r}} G_{p}^{u \bar{u}}-2 d^{r u} \bar{d}^{\bar{r} \bar{u}} g_{p q} . \tag{4.2}
\end{equation*}

Alternating the equality (4.1) with respect to the same pair of indices, we obtain

G_{p}^{r \bar{u}} G_{q}^{u \bar{r}}-G_{q}^{r \bar{u}} G_{p}^{u \bar{r}}=\sum_{a=0}^{3} \sum_{b=0}^{3} \sum_{m=0}^{3} \sum_{n=0}^{3} i g_{p a} g_{q b} \omega^{a m b n} G_{m}^{u \bar{u}} G_{n}^{r \bar{r}} \tag{4.3}
\end{equation*}

The identities (4.2) and (4.3) taken together are equivalent to (4.1).

## 5. The metric connection and its spinor components.

The metric connection $\Gamma$ in $M$ associated with the metric tensor $\mathbf{g}$ is a torsionfree connection satisfying the condition

The equality (5.1) is known as the concordance condition for the metric and connection. In the coordinate form the torsion-free condition is written as

\end{equation*}
$$

As for the concordance condition (5.1), it expands to

The equations (5.2) and (5.3) can be solved with respect to $\Gamma_{i j}^{k}$. They yield

+\sum_{\bar{u}=1}^{2} \sum_{\bar{s}=1}^{2} \frac{L_{\Upsilon_{r}}\left(\bar{d}_{\bar{s} \bar{u}}\right) \bar{d}^{\bar{u} \bar{s}} G_{p}^{i \bar{i}}}{4}+\sum_{u=1}^{2} \sum_{s=1}^{2} \frac{L_{\Upsilon_{r}}\left(d_{s u}\right) d^{u s} G_{p}^{i \bar{i}}}{4}
\end{gather*}
$$

Now let's study the fifth term in the right hand side of the equality (5.44). Applying the identity (5.40) to (5.44), we derive

$$
\begin{equation*}
\sum_{k=1}^{2} \sum_{\bar{s}=1}^{2} \sum_{m=0}^{3} \frac{d^{i k} \bar{d}^{\bar{i} \bar{s}}}{2} \Gamma_{r m p} G_{k \bar{s}}^{m}=\sum_{q=0}^{3} \sum_{m=0}^{3} \frac{\Gamma_{r m p}}{2} g^{m q} G_{q}^{i \bar{i}} \tag{5.45}
\end{equation*}
$$

In order to transform (5.45) we use the formula (5.25). This yields

$$
\begin{gather*}
\sum_{k=1}^{2} \sum_{\bar{s}=1}^{2} \sum_{m=0}^{3} \frac{d^{i k} \bar{d}^{\bar{i} \bar{s}}}{2} \Gamma_{r m p} G_{k \bar{s}}^{m}= \\
=\sum_{q=0}^{3} \sum_{m=0}^{3} \frac{g^{q m} L_{\Upsilon_{r}}\left(g_{p m}\right)}{2} G_{q}^{i \bar{i}}-\sum_{q=0}^{3} \frac{\Gamma_{r p}^{q}}{2} G_{q}^{i \bar{i}} . \tag{5.46}
\end{gather*}
$$

Substituting (5.46) back into the formula (5.44), we get the following equality:

$$
\begin{gather*}
\sum_{k=1}^{2} \mathrm{~A}_{r k}^{i} G_{p}^{k \bar{i}}+\sum_{\bar{k}=1}^{2} \overline{\mathrm{~A}_{r \bar{k}}^{\bar{i}}} G_{p}^{i \bar{k}}=\sum_{q=0}^{3} G_{q}^{i \bar{i}} \Gamma_{r p}^{q}+ \\
+\sum_{q=0}^{3} \frac{G_{p}^{i \bar{i}} \Gamma_{r q}^{q}}{2}-\frac{1}{2} L_{\Upsilon_{r}}\left(G_{p}^{i \bar{i}}\right)-\sum_{m=0}^{3} \sum_{n=0}^{3} \frac{g^{n m} L_{\Upsilon_{r}}\left(g_{n m}\right)}{4} G_{p}^{i \bar{i}}-  \tag{5.47}\\
-\sum_{q=0}^{3} \sum_{m=0}^{3} \frac{g^{q m} L_{\Upsilon_{r}}\left(g_{p m}\right)}{2} G_{q}^{i \bar{i}}-\sum_{k=1}^{2} \sum_{\bar{s}=1}^{2} \sum_{m=0}^{3} \frac{d^{i k} \bar{d}^{\bar{i} \bar{s}} g_{p m}}{2} L_{\Upsilon_{r}}\left(G_{k \bar{s}}^{m}\right)+ \\
+\sum_{\bar{u}=1}^{2} \sum_{\bar{s}=1}^{2} \frac{L_{\Upsilon_{r}}\left(\bar{d}_{\bar{s} \bar{u}}\right) \bar{d}^{\bar{u} \bar{s}} G_{p}^{i \bar{i}}}{4}+\sum_{u=1}^{2} \sum_{s=1}^{2} \frac{L_{\Upsilon_{r}}\left(d_{s u}\right) d^{u s} G_{p}^{i \bar{i}}}{4}
\end{gather*}
$$

Let's proceed to the second term in the right hand side of (5.47). From (5.4) due to the skew symmetry $c_{i j}^{k}=-c_{j i}^{k}$ we derive the formula

$$
\begin{equation*}
\sum_{q=0}^{3} \Gamma_{r q}^{q}=\sum_{q=0}^{3} \sum_{m=0}^{3} \frac{g^{q m} L_{\Upsilon_{r}}\left(g_{q m}\right)}{2} \tag{5.48}
\end{equation*}
$$

Substituting (5.48) back into (5.47), we find that the second term in the right hand side of this formula cancels the fourth term over there. So we have

$$
\begin{gather*}
\sum_{k=1}^{2} \mathrm{~A}_{r k}^{i} G_{p}^{k \bar{i}}+\sum_{\bar{k}=1}^{2} \overline{\mathrm{~A}_{r \bar{k}}^{\bar{i}}} G_{p}^{i \bar{k}}=\sum_{q=0}^{3} G_{q}^{i \bar{i}} \Gamma_{r p}^{q}-\frac{1}{2} L_{\Upsilon_{r}}\left(G_{p}^{i \bar{i}}\right)- \\
-\sum_{q=0}^{3} \sum_{m=0}^{3} \frac{g^{q m} L_{\Upsilon_{r}}\left(g_{p m}\right)}{2} G_{q}^{i \bar{i}}-\sum_{k=1}^{2} \sum_{\bar{s}=1}^{2} \sum_{m=0}^{3} \frac{d^{i k} \bar{d}^{\bar{i} \bar{s}} g_{p m}}{2} L_{\Upsilon_{r}}\left(G_{k \bar{s}}^{m}\right)+  \tag{5.49}\\
\quad+\sum_{\bar{u}=1}^{2} \sum_{\bar{s}=1}^{2} \frac{L_{\Upsilon_{r}}\left(\bar{d}_{\bar{s} \bar{u}}\right) \bar{d}^{\bar{u} \bar{s}} G_{p}^{i \bar{i}}}{4}+\sum_{u=1}^{2} \sum_{s=1}^{2} \frac{L_{\Upsilon_{r}}\left(d_{s u}\right) d^{u s} G_{p}^{i \bar{i}}}{4}
\end{gather*}
$$

The next step is to transform the fourth term in the right hand side of the formula (5.49). For this purpose we recall that $L_{\boldsymbol{\Upsilon}_{r}}$ is the differential operator (2.15). We apply the Leibniz rule for this operator. As a result we get

\begin{aligned}
& \sum_{k=1}^{2} \sum_{\bar{s}=1}^{2} \sum_{m=0}^{3} d^{i k} \bar{d}^{\bar{i} \bar{s}} g_{p m} L_{\Upsilon_{r}}\left(G_{k \bar{s}}^{m}\right)=\sum_{k=1}^{2} \sum_{\bar{s}=1}^{2} \sum_{m=0}^{3} L_{\Upsilon_{r}}\left(d^{i k} \bar{d}^{\bar{i} \bar{s}} g_{p m} G_{k \bar{s}}^{m}\right)- \\
& -\sum_{k=1}^{2} \sum_{\bar{s}=1}^{2} \sum_{m=0}^{3} L_{\Upsilon_{r}}\left(d^{i k}\right) \bar{d}^{\bar{i} \bar{s}} g_{p m} G_{k \bar{s}}^{m}-\sum_{k=1}^{2} \sum_{\bar{s}=1}^{2} \sum_{m=0}^{3} d^{i k} L_{\boldsymbol{\Upsilon}_{r}}\left(\bar{d}^{\bar{i} \bar{s}}\right) g_{p m} G_{k \bar{s}}^{m}- \\
& -\sum_{k=1}^{2} \sum_{\bar{s}=1}^{2} \sum_{m=0}^{3} d^{i k} \bar{d}^{\bar{i} \bar{s}} L_{\Upsilon_{r}}\left(g_{p m}\right) G_{k \bar{s}}^{m}=L_{\Upsilon_{r}}\left(G_{p}^{i \bar{i}}\right)-\sum_{k=1}^{2} \sum_{q=1}^{2} L_{\boldsymbol{\Upsilon}_{r}}\left(d^{i k}\right) d_{k q} \times \\
& \quad \times G_{p}^{q \bar{i}}-\sum_{\bar{s}=1}^{2} \sum_{\bar{r}=1}^{2} L_{\Upsilon_{r}}\left(\bar{d}^{\bar{i} \bar{s}}\right) \bar{d}_{\bar{s} \bar{r}} G_{p}^{i \bar{r}}-\sum_{m=0}^{3} \sum_{q=0}^{3} L_{\mathbf{\Upsilon}_{r}}\left(g_{p m}\right) g^{q m} G_{q}^{i \bar{i}}
\end{aligned}
$$

Note that the quantities $L_{\boldsymbol{\Upsilon}_{r}}\left(d^{i k}\right)$ and $L_{\boldsymbol{\Upsilon}_{r}}\left(\bar{d}^{\bar{i} \bar{s}}\right)$ form two skew-symmetric $2 \times 2$ matrices. It is known that any skew-symmetric $2 \times 2$ matrix is proportional to any other nonzero skew-symmetric $2 \times 2$ matrix. In particular, we can write

$$
\begin{equation*}
L_{\boldsymbol{\Upsilon}_{r}}\left(d^{i k}\right)=U_{r} d^{i k}, \quad L_{\boldsymbol{\Upsilon}_{r}}\left(\bar{d}^{\bar{i} \bar{s}}\right)=\bar{U}_{r} \bar{d}^{\bar{i} \bar{s}} \tag{5.50}
\end{equation*}
$$

The coefficients $U_{r}$ and $\bar{U}_{r}$ in (5.50) can be easily calculated:

$$
\begin{align*}
U_{r} & =\sum_{i=1}^{2} \sum_{k=1}^{2} \frac{L_{\Upsilon_{r}}\left(d^{i k}\right)}{2} d_{k i}=-\sum_{u=1}^{2} \sum_{s=1}^{2} \frac{L_{\Upsilon_{r}}\left(d_{s u}\right) d^{u s}}{2} \\
\bar{U}_{r} & =\sum_{\bar{i}=1}^{2} \sum_{\bar{s}=1}^{2} \frac{L_{\Upsilon_{r}}\left(\bar{d}^{\bar{i} \bar{s}}\right)}{2} \bar{d}_{\bar{s} \bar{i}}=-\sum_{\bar{u}=1}^{2} \sum_{\bar{s}=1}^{2} \frac{L_{\Upsilon_{r}}\left(\bar{d}_{\bar{s} \bar{u}}\right) \bar{d}^{\bar{u} \bar{s}}}{2} \tag{5.51}
\end{align*}
$$

Substituting (5.51) back into (5.50) and using (5.50), we obtain

$$
\begin{align*}
& \sum_{k=1}^{2} \sum_{\bar{s}=1}^{2} \sum_{m=0}^{3} d^{i k} \bar{d}^{\bar{i} \bar{s}} g_{p m} L_{\Upsilon_{r}}\left(G_{k \bar{s}}^{m}\right)=L_{\Upsilon_{r}}\left(G_{p}^{i \bar{i}}\right)+\sum_{u=1}^{2} \sum_{s=1}^{2} \frac{L_{\Upsilon_{r}}\left(d_{s u}\right) d^{u s}}{2} \times \\
& \quad \times G_{p}^{i \bar{i}}+\sum_{\bar{u}=1}^{2} \sum_{\bar{s}=1}^{2} \frac{L_{\boldsymbol{\Upsilon}_{r}}\left(\bar{d}_{\bar{s} \bar{u}}\right) \bar{d}^{\bar{u} \bar{s}}}{2} G_{p}^{i \bar{i}}-\sum_{m=0}^{3} \sum_{q=0}^{3} g^{q m} L_{\boldsymbol{\Upsilon}_{r}}\left(g_{p m}\right) G_{q}^{i \bar{i}} \tag{5.52}
\end{align*}
$$

The last step is to substitute (5.52) back into (5.49). As a result we get

$$
\begin{equation*}
\sum_{k=1}^{2} \mathrm{~A}_{r k}^{i} G_{p}^{k \bar{i}}+\sum_{\bar{k}=1}^{2} \overline{\mathrm{~A}_{r \bar{k}}^{\bar{i}}} G_{p}^{i \bar{k}}=\sum_{q=0}^{3} G_{q}^{i \bar{i}} \Gamma_{r p}^{q}-L_{\Upsilon_{r}}\left(G_{p}^{i \bar{i}}\right) \tag{5.53}
\end{equation*}
$$

Comparing (5.53) with (5.9), we see that these two formulas are equivalent to each other. This means that for the spinor connection with the components (1.3) the second concordance condition (5.7) is also fulfilled. As compared to the paper
[1], in this paper we have verified the formula (1.3) in some other way, though the calculations here are not less huge than those in [1].
